

2021/22 COUNCIL TAX RESOLUTION FOR 1.9% INCREASE

The Authority is recommended to approve as follows:

1. For the purpose of Section 42 A, B of the Local Government Finance Act 1992, the following amounts in respect of 2021/22:
 - (a) The Council Tax Base for 2021/22 as 156,110.0 as notified by the relevant billing authorities.
2. That the Council Tax requirement for the Authority's own purposes for 2021/22 is £12,540,316.
3. That the following amounts be calculated by the Authority for 2021/22 in accordance with Sections 42 to 48 of the Local Government Finance Act 1992 and relevant regulations:-
 - (a) £26,255,113 Being the aggregate of the amounts which the Authority estimates for the items set out in Section 42 to 48 of the Local Government Finance Act 1992 and relevant regulations.
 - (b) £13,714,797 Being the aggregate of the sums which the Authority estimate will be payable to it in respect of Revenue Support Grant £5,353,599, Top Up Grant of £7,434,403, Business Rates income of £1,874,170 and the estimate to be paid to the Collection Funds of the billing authorities of £947,375 as at 31st March 2021, in accordance with Section 99 (3) (b) of the Local Government Finance Act 1988 and the Local Government Charges for England (Collection Fund Surpluses and Deficits) Regulations 1995 amended.
 - (c) £12,540,316 Being the amount by which the aggregate at 3(a) above exceeds the aggregate at 3(b) above, calculated by the Authority in accordance with Section 42B (1) (2) of the Act as its Council Tax requirement for the year.
 - (d) £80.33 Being the amount calculated by the Authority in accordance with Section 44 of the Local Government Finance Act 1992, as the basic amount of Council Tax for the year.
4. That the Authority, in accordance with Section 47 of the Local Government Finance Act 1992, hereby sets the aggregate amounts shown in the tables below as the amounts of Council Tax for 2021/22 for each of the categories of dwellings:

Approve that the Authority's basic amount of Council Tax for 2021/22 is not excessive in accordance with the principles approved under section 52ZB Local Government Finance Act 1992 and that no local referendum will be carried out in relation to Chapter 4ZA of the Local Government Finance Act 1992.
