**33. DECLARATION OF MEMBERS INTERESTS**

It was noted no Declarations of Interests were submitted to the meeting.

**34. MINUTES**

**RESOLVED - that the Minutes of the Executive Committee on 5 August 2024 be confirmed.**

**35. REPORT OF THE CHIEF FIRE OFFICER**

**35.1 Cleveland Fire Brigade's HMICFRS Inspection 2023-25**

The Chief Fire Officer (CFO) provided Members with an update relating to the Brigade's third HMICFRS inspection scheduled to commence on 7 October 2024 with the Strategic Brief and last for six weeks.

He outlined the outcomes of the 2021/22 inspection which found the Brigade to be 'Good' across all three pillars of effectiveness, efficiency and people. In addition, the Brigade's improvement journey was recognised by HMICFRS Roy Wilshire who noted that 12 of the 16 areas highlighted for improvement in the 2018 inspection had been resolved and 4 were being progressed.

**35.1 Cleveland Fire Brigade's HMICFRS Inspection 2023-25 cont.**

The CFO gave assurances that all preparations for the forthcoming inspection were on track and informed Members that the Brigade's Service Liaison Lead was Spencer Rowland with Michelle Skeer OBE QPM appointed as His Majesty's Inspector of Fire and Rescue for the Northern Region.

He noted that the Inspectorate was taking a different approach to grading for the third round with the introduction of 'adequate' between 'good' and 'requires improvement' grades making it difficult to compare to previous years' improvements.

**RESOLVED – That Members noted the current position regarding HMICFRS Round 3 Inspections and the preparation activities required for Cleveland Fire Brigade's inspection in October 2024.**

**35.2 Grenfell Tower Inquiry: Phase 2 Report Overview**

Members considered an overview of the second phase of the Grenfell Tower Inquiry report which was published on 4 September 2024 with a focus on London Fire Brigade's understanding of modern methods of construction, how some building materials behave when exposed to fire and how its officers were trained to respond to fires in high rise buildings.

The CFO referred Members to the Executive Summary report at Appendix 1 and highlighted 'Volume 5: London Fire Brigade's response' which covers a wide range of operational issues including communication, training policy and guidance, incident command and leadership.

He reported that Cleveland Fire Brigade's own Operational Assurance Team had been commissioned to identify operational and organisational learning from the event and disseminate that learning and recommend any improvements where appropriate. This would be shared with Members to consider the wider implications, and the CFO would continue to work with the National Chiefs Council to address all of the operational matters raised in the report.

The Assistant Chief Fire Officer – Community Protection (ACFO-CP) informed Members that since the release of the Phase 1 report in 2020 the Brigade had established a Grenfell Action Plan to capture the relevant recommendations which is monitored regularly and funding allocated to achieve the recommendations. This included procuring smoke hoods to use on casualties, upgrading the incident command system and having evacuation plans in place for all high-rise buildings.
