

ANNUAL STATEMENT OF ASSURANCE 2019/20

REPORT OF THE CHIEF FIRE OFFICER



For Recommendation

1. PURPOSE OF REPORT

- 1.1 The purpose of this report is to enable Members to review and scrutinise the 2019/20 Annual Statement of Assurance.

2. RECOMMENDATIONS

- 2.1 That Elected Members consider the Annual Statement of Assurance 2019/20 attached at Appendix 1.
- 2.2 That Elected Members provide CFA with recommendations for consideration for incorporation into the Annual Statement of Assurance.

3. BACKGROUND

- 3.1 Members will be aware that the Fire and Rescue National Framework for England 2018 (the Framework) sets out the requirement for all fire and rescue authorities to provide annual assurance on financial, governance and operational matters and to show how they have due regard to the requirements included in the Framework and the expectations set out in authorities' own integrated risk management plans.
- 3.2 To demonstrate this, the Framework requires that each authority must publish an Annual Statement of Assurance.
- 3.3 The Statement of Assurance is seen by Government as an important measure that will ensure that FRAs provide local scrutiny arrangements and access to a range of information to help communities influence, and be assured of the robustness of, local delivery arrangements.
- 3.4 The guidance also states that "the Statement of Assurance will be used as a source of information on which to base the Secretary of State's biennial report under section 25 of the Fire and Rescue Act 2004".

4 STATEMENT OF ASSURANCE

- 4.1 The Fire and Rescue National Framework for England (2018) introduced a requirement for all English Fire and Rescue Authorities to publish Statements of Assurance. It states:

‘Fire and rescue authorities must provide annual assurance on financial, governance and operational matters and show how they have had due regard to the expectations set out in their integrated risk management plan and the requirements included in the Framework. To provide assurance, fire and rescue authorities must publish an annual Statement of Assurance’.

- 4.2 One of the principal aims of the Statement of Assurance is to provide an accessible way in which communities, Government, local authorities and our partners may make a valid assessment of our performance. Where relevant information is already set out in a clear, accessible and user friendly way within existing documents, it is acceptable to include extracts or links to these documents within the Statement of Assurance.
- 4.3 The draft Statement of Assurance 2019/20, appended to this report has been produced in line with the official recommended ‘Light Touch’ guidance that was published in May 2013 by the Department Communities and Local Government.
- 4.4 As required the Statement of Assurance should be subject to scrutiny by Elected Members through the Authority’s formal scrutiny process before approval.
- 4.5 Page five to seven provides Members with a short summary of the Risk Profile of the Authority’s area and how we approach our management of these risks through a balanced strategy of Prevention, Protection and Emergency Response.
- 4.6 Pages seven to fourteen of the attached document provides details and assurance on the Authority’s Operational arrangements that address the risks and keep the residents and businesses of the area safe.
- 4.7 Pages fifteen to seventeen provide details and assurance on our financial arrangements including the Authorities arrangements for securing Value for Money.
- 4.8 Pages eighteen to twenty three provide assurance on the effectiveness of the Corporate Governance arrangements of Cleveland Fire Authority.
