Hartlepool lies to the north of Cleveland Fire Authority area and consists of 12 local wards. These wards range from areas of high social deprivation to areas of executive housing. The current population of this area is 93,861 living in 45,337 dwellings.

Specific risks within the District include: A19, Hartlepool Power Station, Marina Development, Retail Parks and Light Engineering, Middleton Grange Shopping Centre, Dock Area and University of Hartlepool Hospital.

SAFER HOMES

- 62% Coverage across the Hartlepool area
- 808 smoke alarms fitted

COMMUNITY ENGAGEMENT

- The Brigade Road and Water Safety Officer attended the crucial crew event in Hartlepool, where they engaged with approximately 450 Year 5 and Year 6 Primary school students from across the Hartlepool area.
- As part of World Mental Health Day, our community advocate in Hartlepool delivered prevention advice to 50 attendees at the Centre for Independent Living. The event was also attended by social services to ensure that we are providing equality of access for these hard to reach members of the community.

CURRENT AND EMERGING ISSUES

Accidental Dwelling Fires

The number of accidental dwelling fires has risen 25% between April and December 2024 when compared to 2023 increasing from 20 to 25. The safety of all residents is the Brigades top priority and measures are in place to tackle this issue including targeted Safer Homes Visits and tailored education.

Accidental Dwelling Fire Injuries

The number of accidental dwelling fire injuries in Hartlepool District increased from 0 in 2023 (April to December) to 2 in 2024. Work continues to make residents as safe as possible in their homes and the Brigade have stringent attendance times which ensure that all house fires have an appliance in attendance within 7 minutes to minimize any damages including injury.

HOTSPOT DATA

- The top 5 wards in Hartlepool for all fire incidents between April and December 2024 accumulatively accounted for 68% of fires across the district.
- De Bruce was the highest ward with 112 fires of which 102 (91%) were deemed as deliberate.
